Families must also complete a Community Partnership Discount Employment Verification Form quarterly after initial application (3/1, 6/1, 9/1, 12/1) and submit to your center/school accounting representative along with proof of employment.

A reminder notice will go out in the family's tuition invoice the month before verification is due.

United States Military Veterans are only required to provide form DD-214 one time with initial application.

Quarterly verification is not required.
